To amend the Howard Theatre Redevelopment Project Great Streets Initiative Tax Increment Financing Act of 2010 to authorize the inclusion of real property possessory interest tax in the tax increment to be used to support the bonds to be issued to finance the Howard Theatre redevelopment project.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Howard Theatre Redevelopment Project Great Streets Initiative Tax Increment Financing Amendment Act of 2011".

Sec. 2. Section 2(2) of the Howard Theatre Redevelopment Project Great Streets Initiative Tax Increment Financing Act of 2010, effective December 7, 2010 (D.C. Law 18-275; D.C. Official Code § 2-1217.34a(2)), is amended by striking the phrase "under Chapter 8 of Title 47 of the District of Columbia Official Code including" and inserting the phrase "under Chapter 8 of Title 47 of the District of Columbia Official Code and the tax under section 47-1005.01 of the District of Columbia Official Code, including" in its place.

Sec. 3. Fiscal impact statement.



Sec. 4. Effective date.


This act shall take effect following approval by the Mayor (or in the event of veto by the Mayor, action by the Council to override the veto), a 30-day period of Congressional review as provided in section 602(c)(1) of the District of Columbia Home Rule Act, approved December
