To amend section 25-723 of the District of Columbia Official Code to extend the hours during which certain alcoholic beverage licensees may operate during the beginning of daylight savings time, and to provide the Chief of Police the authority to suspend the privilege of an extended hour to a licensee whose operation presents a danger to the public health, safety, or welfare; and to amend section 28-2711 of the District of Columbia Official Code to reflect the current period of daylight savings time.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Daylight Savings Time Extension of Hours Act of 2011".

Sec. 2. Section 25-723 of the District of Columbia Official Code is amended as follows:

§ 25-723

(a) Subsection (b) is amended by striking the phrase "§ 25-724" and inserting the phrase "§ 25-724 and subsections (c) and (d) of this section" in its place.

(b) A new subsection (d) is added to read as follows:

"(d)(1) During the beginning of daylight savings time pursuant to § 28-2711, on the second Sunday in March of each year, a licensee under an on-premises retailer's license may sell and serve alcoholic beverages between 3:00 a.m. and 4:00 a.m., if the licensee:

"(A) Registers with the Board;

"(B) Pays a registration fee of \$200; and

"(C) Provides written notification, no later than 10 days prior to the beginning of daylight savings time, to the Board and the Metropolitan Police Department of its extended hours of operation.

"(2) The fees collected pursuant to this subsection shall be used to fund the Reimbursable Detail Subsidy Program in the ABRA.

"(3) The Chief of Police may suspend a licensee's privilege to operate and sell or serve alcoholic beverages during the extended hour authorized by paragraph (1) of this subsection if the licensee's operation presents a danger to the public health, safety, or welfare.

"(4) A violation of paragraph (1) of this subsection shall constitute a secondary tier violation subject to the penalties set forth in § 25-830(d)."


Sec. 3. Section 28-2711 of the District of Columbia Official Code is amended by striking the phrase "2:00 AM on the last Sunday in April of each year until 2:00 AM on the last Sunday in October" and inserting the phrase "2:00 a.m. on the second Sunday in March of each year until 2:00 a.m. on the first Sunday in November" in its place. ^{Amend} § 28-2711

Sec. 4. Fiscal impact statement.


The Council adopts the fiscal impact statement in the committee report as the fiscal impact statement required by section 602(c)(3) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(3)).

Sec. 5. Effective date.

This act shall take effect following approval by the Mayor (or in the event of veto by the Mayor, action by the Council to override the veto), a 30-day period of Congressional review as provided in section 602(c)(1) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(1)), and publication in the District of Columbia Register.
