To amend the Compulsory/No-Fault Motor Vehicle Insurance Act of 1982 to require insurance carriers authorized to sell motor vehicle insurance in the District to provide insurance records to the Department of Motor Vehicles pertaining to their insured customers.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Compulsory/No Fault Motor Vehicle Insurance Amendment Act of 2012".

Sec. 2. Section 4(d) of the Compulsory/No Fault Motor Vehicle Insurance Act of 1982, effective September 18, 1982 (D.C. Law 4-155; D.C. Official Code § 31-2403(d)), is amended by adding a new paragraph (5) to read as follows: Amend § 31-2403

“(5)(A) On the first day of each month, an insurer authorized to sell motor vehicle insurance in the District shall furnish to the Director the following records pertaining to each vehicle insured by it in the District:

- “(i) The owner’s full name and address;
- “(ii) The insurance policy number or binder number;
- “(iii) The commencement date of the motor vehicle insurance policy;
- “(iv) The expiration or termination date of the motor vehicle insurance policy;
- “(v) The operator’s license number, if known;
- “(vi) The corresponding vehicle identification number, if known;

and


- “(vii) Other relevant information the Director may require.
- “(B) The records required by this paragraph shall be submitted or transmitted in electronic files and in compliance with procedures established by the Department.
- “(C) In lieu of requiring insurers to satisfy the requirements of subparagraph (A) of this paragraph, the Director may allow insurers to verify insurance through an online insurance verification system.”.

Sec. 3. Fiscal impact statement.


The Council adopts the fiscal impact statement in the committee report as the fiscal impact statement required by section 602(c)(3) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(3)).

Sec. 4. Effective date.

This act shall take effect following approval by the Mayor (or in the event of veto by the Mayor, action by the Council to override the veto), a 30-day period of Congressional review as provided in section 602(c)(1) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(1)), and publication in the District of Columbia Register.
