IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

OCTOBER 11, 2011

To amend the Fiscal Year 1997 Budget Support Act of 1996 to authorize the Mayor to waive or reduce permit fees for the use of public space, public rights of way, and public structures for projects that convey a public benefit and that do not impose costs on the District government; and to amend section 24-225 of the District of Columbia Municipal Regulations to allow for the waiver or reduction of permit fees for the use of public space, public rights of way, and public structures for projects that convey a public benefit and do not impose costs on the District government.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Public Space Permit Fee Waiver Amendment Act of 2011".

Sec. 2. Title VI of the Fiscal Year 1997 Budget Support Act of 1996, effective April 9, 1997 (D.C. Law 11-198; D.C. Official Code § 10-1141.01 *et seq.*), is amended by adding a new section 603a to read as follows:

"Sec. 603a. Waiver or reduction of permit fees for the occupation of public space, public rights of way, and public structures.

"The Mayor may waive or reduce any permit fee, except for the application fee, to occupy or otherwise use public space, public rights of way, or public structures for a project that:

"(1) Is conducted by a Business Improvement District or Community Improvement District established pursuant to the Business Improvement Districts Act of 1996, effective May 29, 1996 (D.C. Law 11-134; D.C. Official Code § 2-1215.01 *et seq.*);

"(2) In the Mayor's determination, serves a public benefit;

"(3) Does not impose costs on the District government; and

"(4) Does not involve commercial sponsorship."

Sec. 3. Section 24-225 of the District of Columbia Municipal Regulations is amended by adding a new subsection 225.12 to read as follows:

DCMR

"225.12. Except for the application fee, permit fees for the occupancy or use of public

space, public rights-of-way, or public structures may be waived or reduced for any project that:

“(1) Is conducted by a Business Improvement District or Community Improvement District established pursuant to the Business Improvement Districts Act of 1996, effective May 29, 1996 (D.C. Law 11-134; D.C. Official Code § 2-1215.01 *et seq.*);

“(2) In the Mayor’s determination, serves a public benefit;

“(3) Does not impose costs on the District government; and

“(4) Does not involve commercial sponsorship.”.

Sec. 4. Fiscal impact statement.


The Council adopts the fiscal impact statement in the committee report as the fiscal impact statement required by section 602(c)(3) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(3)).

Sec. 5. Effective date.

This act shall take effect following approval by the Mayor (or in the event of veto by the Mayor, action by the Council to override the veto), a 30-day period of Congressional review as provided in section 602(c)(1) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(1)), and publication in the District of Columbia Register.
