To amend section 28-3814 of the District of Columbia Official Code to apply the debt collection restrictions to creditors as well as debt collectors and to prohibit creditors, collection agencies, and their representatives or agents from calling consumers before 8 a.m. and after 9 p.m. in the District of Columbia.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Creditor Calling Act of 2011".

Sec. 2. Section 28-3814 of the District of Columbia Official Code is amended as follows:

(a) Subsection (b) is amended by adding a new paragraph (1A) to read as follows:

"(1A) "creditor" means a claimant or other person holding a claim."

(b) Subsection (c) is amended by striking the phrase "debt collectors" and inserting the phrase "creditor or debt collector" in its place.

(c) Subsection (d) is amended by striking the phrase "debt collector" and inserting the phrase "creditor or debt collector" in its place.

(d) Subsection (e) is amended by striking the phrase "debt collector" and inserting the phrase "creditor or debt collector" in its place.

(e) Subsection (f) is amended by striking the phrase "debt collector" and inserting the phrase "creditor or debt collector" in its place.

(f) Subsection (g) is amended by striking the phrase "debt collector" and inserting the phrase "creditor or debt collector" in its place.

(g) Subsection (h) is amended by striking the phrase "debt collector" and inserting the phrase "creditor or debt collector" in its place.

(h) Subsection (i) is amended by striking the phrase "debt collector" and inserting the phrase "creditor or debt collector" in its place.

(i) Subsection (j)(1) is amended by striking the phrase "debt collector" and inserting the phrase "creditor or debt collector" in its place.

(j) A new subsection section (k) is added to read as follows:


"(k) No creditor, debt collector, or collection agency, or their representatives or agents shall contact consumers by telephone before 8 a.m. and after 9 p.m. EST or EDT, whichever time zone is in effect."

Sec. 3. Fiscal impact statement.


The Council adopts the fiscal impact statement in the committee report as the fiscal impact statement required by section 602(c)(3) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(3)).

Sec. 4. Effective date.

This act shall take effect following approval by the Mayor (or in the event of veto by the Mayor, action by the Council to override the veto), a 30-day period of Congressional review as provided in section 602(c)(1) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(1)), and publication in the District of Columbia Register.


