To amend the Procurement Practices Reform Act of 2010 to exempt from the act's coverage private developments which involve a disposition of public land, the District of Columbia Retirement Board, and procurement of services related to the construction of a Fire and Emergency Medical Services Department facility at the Walter Reed Army Medical Center.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Disposed Real Property Procurement Clarification Amendment Act of 2011".

Sec. 2. Section 105(c) of the Procurement Practices Reform Act of 2010, effective April 8, 2011 (D.C. Law 18-371; D.C. Official Code § 2-351.05(c)), is amended as follows:

§ 2-351.05

(a) Paragraph (11) is amended by striking the word "and" at the end.

(b) Paragraph (12) is amended by striking the period and inserting a semicolon in its place.

(c) New paragraphs (13), (14), and (15) are added to read as follows:

"(13) The procurement of services for the design, development, and construction of a facility on real property that has been disposed of pursuant to the authority in section 1 of An Act Authorizing the sale of certain real estate in the District of Columbia no longer required for public purposes, approved August 5, 1939 (53 Stat. 1211; D.C. Official Code § 10-801); provided, that the construction of the facility is required by the Land Disposition Agreement, or similar agreement, governing the disposition of the real property.

"(14) The District of Columbia Retirement Board; and

"(15) The procurement of services for the demolition of an existing facility and the design, development, and construction of a facility comprised of a fire station and office space for the Fire and Emergency Medical Services Department on real property located at Butternut Street and Georgia Avenue, N.W., at the Walter Reed Army Medical Center."

Sec. 3. Fiscal impact statement.


The Council adopts the fiscal impact statement in the committee report as the fiscal impact statement required by section 602(c)(3) of the District of Columbia Home Rule Act,



Sec. 4. Effective date.

This act shall take effect following approval by the Mayor (or in the event of veto by the Mayor, action by the Council to override the veto), a 30-day period of Congressional review as provided in section 602(c)(1) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(1)), and publication in the District of Columbia Register.
