To establish within the Department of Health the Senior HIV/AIDS Education and Outreach Program to train seniors to serve as peer educators, and to require the Department of Health to administer the program.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the “Senior HIV/AIDS Education and Outreach Program Establishment Act of 2012”.

Sec. 2. Definitions.

For the purposes of this act, the term:

- (1) “AIDS” means acquired immune deficiency syndrome.
- (2) “Department” means the Department of Health.
- (3) “HIV” means the human immunodeficiency virus.
- (4) “Program” means the Senior HIV/AIDS Education and Outreach Program established by section 3.
- (5) “Senior” means an individual 50 years of age or older.

Sec. 3. Senior HIV/AIDS Education and Outreach Program establishment.

There is established within the Department the Senior HIV/AIDS Education and Outreach Program, which shall train seniors to provide information to other seniors on how to prevent the transmission of HIV and to engage in education and outreach on issues related to HIV and AIDS with community-based providers that serve seniors in the District.

Sec. 4. Program administration.

(a) The Department shall:

- (1) Administer the Program;
- (2) Recruit seniors to participate in the Program;
- (3) Determine the training curriculum; and
- (4) Schedule no fewer than 8 education or community-outreach events annually, which shall be led by seniors who have successfully completed the Program. Each year, at least one event shall be held in each ward.

(b) The Department may contract with a community provider to train the seniors

participating in the Program.

(c) Subject to the availability of funds, the Department may provide a stipend to Program participants.

Sec. 5. Fiscal impact statement.


The Council adopts the fiscal impact statement in the committee report as the fiscal impact statement required by section 602(c)(3) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(3)).

Sec. 6. Effective date.

This act shall take effect following approval by the Mayor (or in the event of veto by the Mayor, action by the Council to override the veto), a 30-day period of Congressional review as provided in section 602(c)(1) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(1)), and publication in the District of Columbia Register.
