



A BILL

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

Councilmember Kenyan R. McDuffie introduced the following bill, which was referred to the Committee on \_\_\_\_\_.

To amend An Act to prohibit the sale of tobacco to minors under sixteen years of age in the District of Columbia to prohibit tobacco sales to individuals under the age of 21; and to amend Chapter 24 of Title 27 of the District of Columbia Official Code to prohibit the issuance of vending machine operator's licenses for the sale of tobacco products in an establishment that admits persons under the age of 21.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Prohibition Against Selling Tobacco Products to Individuals Under 21 Amendment Act of 2015".

Sec. 2. An Act to prohibit the sale of tobacco to minors under sixteen years of age in the District of Columbia, approved February 7, 1891 (26 Stat. 736; D.C. Official Code § 7-1721.01

2 (a) Section 3 (D.C. Official Code § 7-1721.02) is amended as follows:

3 (1) Subsection (a) is amended by striking the number “18” and inserting the

9 (b) Section 4 is amended as follows:

10 (1) Subsection (a) is amended by striking the number “18” and inserting the

12 (2) Subsection (b) is amended by striking the number “18” and inserting the  
13 number “21” in its place.

14 Sec. 3. Section 47-2404(b)(3)(A) of the District of Columbia Official Code is amended  
15 by striking the number “18” and inserting the number “21” in its place.

16 Sec. 4. Fiscal impact statement.

17 The Council adopts the fiscal impact statement in the committee report as the fiscal  
18 impact statement required by section 602(c)(3) of the District of Columbia Home Rule Act,  
19 approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-206.02(c)(3)).

20 Sec. 5. Effective date.

21 This act shall take effect following approval by the Mayor (or in the event of veto by the  
22 Mayor, action by the Council to override the veto), a 30-day period of Congressional review as  
23 provided in section 602(c)(1) of the District of Columbia Home Rule Act, approved December

- 1 24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(1)), and publication in the District of
- 2 Columbia Register.
