AMENDMENT #1:

Part B of Section 2 is amended as follows:

- (a) "Government Direction and Support" is amended as follows:
- (1) Lead-in language is amended by striking the phrase "\$867,694,000 (including \$754,835,000" and inserting the phrase "\$867,194,000 (including \$753,277,000" in its place.
- (2) Paragraph (2) is amended by striking the phrase "\$6,229,000" and inserting the phrase "\$5,729,000" in its place.
 - (b) "Public Education" is amended as follows:
- (1) Lead-in language is amended by striking the phrase "\$2,613,906,000 (including \$2,283,927,000" and inserting the phrase "\$2,614,406,000 (including \$2,285,266,000" in its place.
- (2) Paragraph (12) is amended by striking the phrase "\$17,366,000" and inserting the phrase "\$17,866,000" in its place.

RATIONALE:

This amendment reduces one-time funding by \$500,000 for the "education research consortium pilot" proposed at the Office of the D.C. Auditor, and increases one-time funding by \$500,000 for out-of-school time grant awards at the Office of Out-of-School Time Grants and Youth Outcomes under the Deputy Mayor for Education. An initial needs assessment issued by the Office in October 2017 identified that 5,900 at-risk students do not have access to subsidized after-school programming and 25,600 at-risk students do not have access to subsidized summer programming. Parents and advocates have estimated that \$25M is required to close the gap. The Council's proposed budget for out-of-school time programming, at the Office and DPR, is about \$20.3M and this additional funding would get D.C. closer to addressing the need.
