
Enclosed for consideration and approval by the Council of the District of Columbia is proposed emergency legislation, the "Modifications to Exercise Option Year Three (3) of Contract No. CW43271 with Synergetic Information Systems, Inc. Approval and Payment Authorization Emergency Act of 2019" for Mission Oriented Business Integration Services (MOBIS). This contract is an IDIQ procurement vehicle with the minimum amount of \$10.00 and a maximum amount of \$950,000.00. This modification will increase the not-to-exceed amount of Option Year Three (3) to \$10,000,000.00 for the period from May 3, 2019 through May 2, 2020.

Council action is necessary since this modification increases the contract more than \$1,000,000 during a 12-month period. The Chief Financial Officer has certified that funds for the minimum quantity are available for FY2019.

A PROPOSED RESOLUTION

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To declare the existence of an emergency with respect to the need to approve Modification Nos. 5, 6, 7, 8, and 9 to Contract No. CW43271 with Synergetic Information Systems, Inc. to provide Mission Oriented Business Integration Services (MOBIS), and to authorize payment for the goods and services received and to be received under the contract.

RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this resolution may be cited as the “Modifications to Exercise Option Year Three (3) of Contract No. CW43271 with Synergetic Information Systems, Inc. Approval and Payment Authorization Emergency Declaration Resolution of 2019”.

Sec. 2. (a) There exists a need to approve Modification Nos. 5, 6, 7, 8, and 9 to Contract No. CW43271 with Synergetic Information Systems, Inc. for Mission Oriented Business Integration Services (MOBIS), and to authorize payment for the goods and services received and to be received under Modification Nos. 5, 6, 7, 8, and 9.

(b) By Modification No. 5, dated April 30, 2019, the Office of Contracting and Procurement exercised Option Year Three (3) of Contract No. CW43271 with Synergetic Information Systems, Inc. the period from May 3, 2019 through May 2, 2020 in the not-to-exceed amount of \$950,000.00.

1 (c) Modification No. 6, dated April 30, 2019, was an administrative modification
2 that added no money.

3 (d) Modification No. 7, dated April 30, 2019, was an administrative modification
4 that added no money.

5 (e) Modification No. 8, dated May 24, 2019, was an administrative modification
6 that added no money.

7 (f) Modification No. 9 is now necessary to increase the not-to-exceed amount of
8 Option Year Three (3) of Contract No. CW43271 with Synergetic Information Systems,
9 Inc. by \$9,050,000, bringing the total not-to-exceed amount for the period from May 3,
10 2019 through May 2, 2020 to \$10,000,000.

11 (g) Council approval is required by section 451(b) of the District of Columbia
12 Home Rule Act, approved December 24, 1973 (87 Stat. 803; D.C. Official Code § 1–
13 204.51(b)) since these modifications increase the contract to more than \$1,000,000 during
14 a 12-month period.

15 (h) Approval is necessary to allow the continuation of these vital services.
16 Without this approval, Synergetic Information Systems, Inc. cannot be paid for goods and
17 services provided in excess of \$1,000,000 for the contract period from May 3, 2019
18 through May 2, 2020.

19 Sec. 3. The Council of the District of Columbia determines that the
20 circumstances enumerated in section 2 constitute emergency circumstances making it
21 necessary that the Modifications to Exercise Option Year Three (3) of Contract No.
22 CW43271 with Synergetic Information Systems, Inc. Approval and Payment
23 Authorization Emergency Act of 2019 be adopted after a single reading.

Sec. 4. This resolution shall take effect immediately.
